

## INTRODUCTION

## RISING FUNERAL COSTS

---

With funeral costs rising in excess of the annual rate of inflation, it is an unfortunate fact that, budgeting for a funeral by traditional means may no longer be sufficient to cover the costs.

According to the Sun Life Cost of Dying Report 2013, average funeral costs have risen from £1,230 in 1997 to £4,000.

## 3RD PARTY CHARGES

---

(also known as disbursements)

Are cost elements of a funeral that are outside of the funeral director's control. They cover cremation or internment (burial) fees, doctor's fees and minister's fees. Currently, the national average for 3rd Party Charges is £1,000. All Safe Hands Funeral Plans (with the exception of the Topaz plan) include an allowance of £1,200 to cover 3rd Party Charges.

\*\*Additional mileage (if applicable) will be charged at a current rate of £1 per mile.

## BURIAL PLOTS

---

Please note that the cost of a burial plot is not included in the plan. You do not need to have purchased your plot before or at the same time as you purchase your plan. However, if you have purchased your plot, the details should be added to your plan. Also if you wish to obtain a plot, you may buy this independently or with the assistance of Safe Hands.

## FLEXIBILITY

---

Safe Hands offers an Either / Or option that allows a single plan to be “shared” between two people. The benefit of the plan can be applied either at first death, or at the second.

## PAYMENT METHODS

---

The fee for your plan can be paid in full on application. Also, with a minimum deposit of £250, you can spread the cost interest free over 1 or 2 years by monthly instalments over. An interest rate of 4% will be added to the cost of your plan if you wish to spread the cost over 3, 5 or 10 years.
